

Care Pathways & Centralized Coordination System: Improving Health Service Delivery for Single Adults Experiencing Homelessness

Starting in 2021, the NYC Department of Homeless Services (DHS) implemented systems to identify clients in the single adult shelter system at high risk for ER visits, inpatient hospitalization, criminal justice system involvement, and harm to self and others. Interventions included cross-agency coordination (City/State DOH, State OMH, OPWDD and others), case conferences, and collaboration with hospitals and community-based providers. As part of the intervention, DHS has developed defined Care Pathways for the more common conditions affecting high risk clients, including: alcohol use disorder, opioid use disorder, serious mental illness, physical disability, intellectual or developmental disabilities, and chronic conditions (i.e., diabetes or end stage organ disease). These Care Pathways are multidisciplinary, unique to the population, and are intended to reduce the risk of harm and improve quality of life. They take into account both available resources and lack of social supports for clients. The presentation will focus on systems for centralized coordination, as well as describe the multi-disciplinary Care Pathways that have been developed.
